



## ADVENTURE RACE AUSTRALIA PARENTAL CONSENT ACKNOWLEDGEMENT, WAIVER AND RELEASE COMPETITORS

**WARNING:** THIS IS A LEGAL DOCUMENT THAT AFFECTS YOUR RIGHTS. PLEASE READ ALL OF (2 PAGES) THE DOCUMENT CAREFULLY. ALL PARENTS/GAURDIANS MUST SIGN THIS FORM.

1. I understand and acknowledge that participating in 'Adventure Race Australia' (The Event) is dangerous. The Event may involve mountain biking, trekking, running, navigation, rafting, canoeing, abseiling, use of a tyrolean traverse and/or a flying fox, traversing isolated and remote tracks, and other unspecified surprise activities. I am aware of the hazards involved and acknowledge that there is always risk of injury (including permanent injury, mental injury, paralysis and death) and damage to property. The hazards include, but are not limited to remoteness from assistance or medical aid, the extremely strenuous nature of the Event including becoming lost, vehicle traffic, actions of participants and spectators, weather conditions, hypothermia and heat exhaustion, condition or suitability of participant's equipment. In my judgment the participant named below who is under my care has sufficient competence, experience and equipment to participate in all Event activities in a manner safe to themselves and others.

2. As the Legal Guardian of the Participant named below I certify that the participant is physically fit and can swim 50m unaided and has sufficiently trained for participation in the Event and has not been advised otherwise by a qualified medical person that they can not participate in the Event and that they have been given the opportunity by the organiser to attend a pre event briefing session (held on the day of the Event).

3. In consideration of being allowed to participate in the Event, the participant who is under my guardianship (on their own behalf and on behalf of their executors, administrators, heirs, next of kin, successors and assigns):

- a. WAIVE, RELEASE AND DISCHARGE from any and all liability for death, disability, personal injury, property damage, property theft and all other risks, claims or actions of any kind (including breach of contract, acts of negligence to the fullest extent permitted by law) whatsoever and however occurring, together with any legal fees incurred as a result of any such claim whether it is valid or not, which I at any time had or have as a result of or in connection with, directly or indirectly, participation in and travelling to and from the Event the following person or entities: Allura Pty Ltd (**In 2 Adventure**), Event sponsors, Event producers, volunteers, community organisations, all State, Federal and Local Government authorities in which the Event may be staged and the owners, licensees or occupiers of any property upon which the participant enters and their (its) respective officers, directors, employees, independent contractors, sponsors, representatives, agents, members and volunteers, including medical and paramedical personal appointed for the Event;
- b. INDEMNIFY AND HOLD HARMLESS the persons or entities mentioned in paragraph 3(a) from any and all liabilities, claims or actions (including negligence) whatever or however caused arising as a result of or in connection with, directly or indirectly, participation in and travelling to and from the Event, including any claim by the participant's (or their teams) support crew or any person assisting the participant or their team.

4. I acknowledge that the participant is responsible for their personal possessions and equipment during the Event.

5. I accept the communications, search, rescue and medical aid arrangements put in place by the organisers. I understand and agree that in the first instance participants are responsible for the provision of first aid to themselves and those around them. As a competitor the participant is responsible for themselves or their team's timely removal from the course to a medical facility. I give my consent for the participant to receive any first aid and medical treatment which may be deemed advisable in the event of accident, injury and/or illness as a result of their involvement in the Event.

6. I certify that the medical information supplied on the entry form is true and I consent to and authorise that information to be provided to any medical practitioner, ambulance officer or any person involved or associated with any medical treatment or assistance that may be given to the participant as a result of their



participation in the Event, regardless of whether the treatment is given. I acknowledge that I have disclosed to In 2 Adventure in writing any relevant medical conditions that may endanger the participant or others during the event.

7. I agree to allow the participants photograph, video, multimedia or film likeness and or name to be used for advertising, promotion and/or any legitimate purpose by In 2 Adventure, its sponsors or assigns without payment or compensation.

8. I acknowledge that the Event arranged insurance covers the participant for public liability whilst participating in this event. I am responsible for the participant's personal accident insurance and ambulance cover.

9. I acknowledge that the organisers reserve the right to alter the advertised course if conditions warrant. I agree that the organisers reserve the right to cancel the Event due to weather conditions, natural disaster, "acts of god", terrorism, war or any other reason so deemed by the organisers, and that the entry fee will be non-refundable.

10. I acknowledge that the organisers reserve the right to alter the advertised course if conditions warrant. If conditions warrant the cancellation or postponement of the Event, I accept that no refunds will be issued.

11. I agree that the participant will abide by the Event rules and directions of officials and I understand that the participant's entry may be voided if through their actions or behaviour, in the opinion of the organisers, they break any of the rules or they bring the Event into disrepute. I further understand that the organisers reserve the right to reject any entry without having to justify their actions.

12. I certify that as the legal guardian of the participant named below that:

- a. I have carefully read and fully understood this document (2 pages);
- b. I am the parent/guardian of the participant named in 13(e) and have been honest and open in all disclosures relating to the participant and team guardian.
- c. The participant named below will be fifteen(15) years of age or older before the Event starts;
- d. I agree that the person named at 13(f) will participate in the team with the participant named in 13(e) and will be a responsible guardian for the participant on the day of the event; and
- e. I grant my consent for the participant in 13(e) to take part in the Event.
